3. Supervising the Executive Management Board by the Board of Directors:

In the first 6 months of 2025, the Board of Directors (BOD) continued to effectively perform its supervisory function over the Company's Executive Management Board and the Hospital Executive Management. In addition to discussions and exchanges at official meetings of the Board of Directors or the Executive Management Board, the Chairman of the Board of Directors and members regularly exchanged via phone, email, online meetings or worked privately with each member of the Executive Management Board to seriously implement the resolutions of the General Meeting of Shareholders and the Board of Directors. At the same time, supervision also helps the Board of Directors promptly grasp the effectiveness of production and business activities and the progress of implementing the Company's set goals.

The supervision of the Board of Directors is always carried out on the basis of ensuring the Company's operations are stable, favorable, and in compliance with the provisions of law, the Company's Charter and the Internal Regulations on Corporate Governance.

4. Activities of the Board of Directors' subcommittees (if any):

On July 8, 2025, the Board of Directors (BOD) of TNH Hospital Group Joint Stock Company issued a decision to establish specialized Committees under the Board of Directors, including: Audit Committee, Procurement and Bidding Committee, Risk Management Committee, Quality Committee, Human Resources and Remuneration Committee, Planning and Budget Committee.

Currently, due to their recent establishment, the Committees are in the process of developing, drafting and finalizing their operating regulations, assigning tasks, and establishing internal coordination procedures between the Committees and the Board of Directors, the Executive Management Board and specialized departments.

Although only in operation since July 2025, the Committees have initially implemented a number of key tasks as follows:

Organize internal meetings to determine the scope of work and assign responsibilities to each member;

Participate in giving comments on draft regulations and procedures related to internal audit, risk management, procurement - bidding, and quality control of medical services;

Coordinate with the Executive Management Board to review and preliminarily evaluate the 2025 plan targets to prepare for the 2026 plan.

Propose preliminary contents for senior human resource planning and review of salary and bonus policies in line with the Company's development orientation.

In addition, the Committees have also initially developed a roadmap for implementing activities in 2026, including: organizing regular meetings, establishing an independent reporting mechanism to the Board of Directors, evaluating the performance of each area of responsibility, thereby improving governance capacity and ensuring that the Company's operations comply with legal regulations, the Company's Charter, as well as public company governance practices.

3. Supervising Board of Directors, Executive Management Board and shareholders by Board of Supervisors:

In the first 6 months of 2025, the Board of Supervisors has performed well its supervisory function over the Board of Directors, the Executive Management Board and ensured the rights of shareholders.
